





APPROVAL WITHIN A DAY

NGO Darpan Unique ID is mandatory to all entities seeking registration under Foreign Contribution Regulation Act (FCRA), Prevention of Money Laundering (Maintenance of Records) Amendment Rules, Income Tax Act for seeking income tax exemption etc. and also mandatory for those entities seeking Government Grants under various schemes of the Government.

REGISTER YOUR NGO UNDER E-ANUDAN

E-Anudaan is an online platform that allows NGOs to apply for grants under various government schemes. This portal automates the application process and simplifies the procedure for disbursing grants.


